ANR Definition of 100% Smoke-free: Municipalities with ordinances or regulations that include all *workplaces* (workplaces include both public and private non-hospitality workplaces, including, but not limited to, offices, factories, and warehouses), that do not allow smoking in attached bars or separately ventilated rooms and do not include workplace size exemptions.
